- A. _____ ("Student") desires to participate in mission trips and field trips sponsored by Deer Park First Baptist Church ("Church"). _____ and _____ ("Parents") are the parents of the Student and want Student to participate in mission and field trips.
- B. Student and Parents understand that certain dangers that result from Student's participation in the mission trip or field trip are foreseeable, such as illness without access to adequate medical facilities for treatment, political unrest that may result in injury, imprisonment or death, accidents may occur with no advance notice, hostilities that may result in my being held hostage, or being stranded and not being able to return to the Church. Student and Parents understand that this list of dangers is not comprehensive.
- C. Student and Parents understand that the dangers are beyond the control of Church, but Student still wants to participate. Student and Parents recognize that Church will not be responsible to remedy Student's situation, including the payment of ransom or bribes.
- D. Student and Parents recognize most United States liability insurance policies do not cover Student outside the United States and that he/she is responsible for securing insurance to cover Student's activities on the mission trip or field trip.

AGREEMENT

BE IT KNOWN, that Student and Parents, for and in consideration of being allowed to participate in mission trips or field trips, and other valuable consideration received from Church, the receipt of which is hereby acknowledged, do hereby remise, release, acquit, satisfy, and forever discharge the said Church, of and from all manner of actions, causes of action, suits, debts, covenants, contracts, controversies, agreements, promises, claims and demands whatsoever, which said Student and Parents ever had, now has, or which any personal representative, successor, heir or assign of said Student and Parents, hereafter can, shall or may have, against said Church, by reason of any matter, cause or thing whatsoever, related in any way to Student's participation in mission trips or field trips sponsored by Church.

Student and Parents further agree to indemnify Church from all liabilities arising in favor of third parties resulting from Student's conduct while on the mission trip or field trip.

Student and Parents agree to be responsible for any expenses that exceed Church's budget for the trip, including early return expenses or emergency evacuation expenses.
